Consent for personal data processing

3. The consent was issued for the processing of personal data for the following purposes:

- 6. The consent is valid until the moment it is withdrawn by the User. The Consent terminates from the date specified in the User's application for withdrawal of the Consent to PD processing, but not earlier than the date following the date of actual receipt by the Operator of the withdrawal of the Consent.

I hereby request to consider the moment of marking the relevant field (or clicking on the appropriate button) in the Form and/or clicking on the button to submit the Form on any page of the Website and/or its Service as **the date and time of generation, confirmation and sending of the Consent**.
