# TR CU 021/2011 "On the Safety of Food Products"

## Chapter 4. Conformity assessment (confirmation)

---



Article 21. Forms of assessment (confirmation) of compliance for food products and processes of production (manufacturing), storage, transportation, distribution, and disposal

The evaluation (confirmation) of compliance for food products, excluding non-industrial food products and food products from catering enterprises, to the requirements of technical regulations and/or technical regulations of the Customs Union for specific types of food products is conducted in the following forms:

- confirmation (declaration) of compliance for food products;
- state registration of specialized food products;
- state registration of new types of food products;
- veterinary and sanitary examination.



# Documents confirming the quality and safety of food products

## Article 22. The applicant during the assessment (confirmation) of food product conformity

---



- During the assessment (confirmation) of food product conformity, excluding state control (supervision), the applicant can be a legal entity or an individual acting as an individual entrepreneur registered in accordance with the legislation of the Customs Union member state on its territory, or acting as a manufacturer or seller, or performing the functions of a foreign manufacturer based on a contract with them in terms of ensuring the conformity of the supplied food products to the requirements of this technical regulation.
- The applicant is obligated to ensure conformity of food products to the requirements established by this technical regulation and other technical regulations of the Customs Union that apply to them.



## Article 23. Declaration of conformity

---

- Food products introduced into the Customs Union's customs territory are subject to declaration of conformity, excluding:
  - unprocessed food products of animal origin;
  - specialized food products;
  - vinegar.
- The declaration of conformity of food products to the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products is carried out by adopting a declaration of conformity, at the applicant's discretion, based on their own evidence and/or evidence obtained with the involvement of a third party.
- The declaration of conformity of food products is carried out according to one of the declaration schemes established by these technical regulations, at the applicant's choice, unless otherwise stipulated by the technical regulations of the Customs Union for specific types of food products.
- Technical regulations of the Customs Union for specific types of food products may establish different schemes for declaring conformity.



- 
- When declaring conformity based on their own evidence, the applicant independently compiles evidentiary materials to confirm the conformity of food products to the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products.
  - Evidentiary materials should include the results of investigations (tests) that confirm the fulfillment of the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products. Such investigations (tests) can be conducted in the applicant's own testing laboratory or in another testing laboratory under a contract with the applicant.
  - Evidentiary materials, apart from the documents specified in part 7 of this article, can include other documents chosen by the applicant, unless otherwise stipulated by the technical regulations of the Customs Union for specific types of food products, which served as the basis for confirming the conformity of the declared food products to the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products.



# 1d declaration scheme

---

- Scheme 1d includes the following procedures:
  - the creation and analysis of technical documentation;
  - the implementation of production control;
  - the testing of product samples;
  - the acceptance of the registration of the declaration of conformity;
  - the application of a single mark for product circulation in the market of the Customs Union member states.
- The applicant takes all necessary steps to ensure that the production (manufacturing) process is stable and guarantees the compliance of food products with the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products, forms technical documentation, and conducts its analysis.
- The applicant ensures the implementation of production control.
- To control the conformity of food products to the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products, the applicant conducts tests on food product samples. Testing of food product samples is carried out at the discretion of the applicant in a testing laboratory or an accredited testing laboratory.
- The applicant prepares a declaration of conformity and registers it based on the notification principle.
- The applicant applies a unified mark of product circulation in the markets of the Customs Union member states, unless otherwise specified by these technical regulations and/or technical regulations of the Customs Union for specific types of food products.



## 2d declaration scheme

---

- Scheme 2d includes the following procedures:
  - the creation and analysis of technical documentation;
  - the testing of a batch of food products;
  - the acceptance of the registration of the declaration of conformity;
  - the application of a single mark for product circulation in the market of the Customs Union member states.
- The applicant creates technical documentation and conducts its analysis.
- The applicant carries out tests on food product samples to confirm the declared conformity of such products to the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products. Testing of food product samples (single item) is carried out at the discretion of the applicant in a testing laboratory or an accredited testing laboratory.
- The applicant prepares a declaration of conformity and registers it based on the notification principle.
- The applicant applies a unified mark of product circulation in the markets of the Customs Union member states, unless otherwise specified by these technical regulations and/or technical regulations of the Customs Union for specific types of food products.





## 3d declaration scheme

---

- Scheme 3d includes the following procedures:
  - the creation and analysis of technical documentation;
  - the implementation of production control;
  - the testing of food product samples;
  - the acceptance of the registration of the declaration of conformity;
  - the application of a single mark for product circulation in the market of the Customs Union member states.
- The applicant takes all necessary steps to ensure that the production (manufacturing) process is stable and guarantees the compliance of food products with the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products, forms technical documentation, and conducts its analysis.
- The applicant ensures the implementation of production control.
- To control the conformity of food products to the requirements of these technical regulations and/or technical regulations of the Customs Union for specific types of food products, the applicant conducts tests on food product samples. Testing of food product samples is carried out in an accredited testing laboratory.
- The applicant prepares a declaration of conformity and registers it based on the notification principle.
- The applicant applies a unified mark of product circulation in the markets of the Customs Union member states, unless otherwise specified by these technical regulations and/or technical regulations of the Customs Union for specific types of food products.



## The declaration of conformity should contain the following information:

---

- Name and location of the applicant;
- Name and location of the manufacturer;
- Information about the object of conformity assessment that allows for its identification;
- The name of these technical regulations or the technical regulations of the Customs Union for specific types of food products, to which the products are confirmed to conform;
- The applicant's statement about the safety of the food products when used as intended and the measures taken by the applicant to ensure the food products conform to the requirements of these technical regulations or the technical regulations of the Customs Union for specific types of food products;
- Information about conducted examinations (tests) and measurements, as well as documents that served as the basis for confirming the conformity of the food products to the requirements of these technical regulations or the technical regulations of the Customs Union for specific types of food products;
- The validity period of the declaration of conformity;
- Other information as stipulated by the relevant technical regulations of the Customs Union.

The validity period of the declaration of conformity is established by the applicant, unless otherwise specified by the technical regulations of the Customs Union for specific types of food products.

If there are changes in the mandatory requirements for food products, the evidentiary materials must be updated to confirm compliance with these requirements. In this case, the adoption of a new declaration of conformity is not required.

Member states of the Customs Union maintain records of accepted declarations of conformity.



## Article 24. State registration of specialized food products

---

Specialized food products are subject to state registration.

Specialized food products include:

- food products for infant nutrition, including drinking water for infants;
- food products for dietary therapeutic and dietary preventive nutrition;
- medicinal table and medicinal natural mineral water;
- food products for the nutrition of athletes, pregnant women, and nursing mothers;
- dietary supplements.

The aforementioned food products are permitted for production (manufacturing), storage, transportation, and distribution following their state registration in accordance with established procedures.





- 
- State registration of specialized food products is carried out at the stage of their preparation for production (manufacturing) on the customs territory of the Customs Union, and for specialized food products imported into the customs territory of the Customs Union — prior to their import into the customs territory of the Customs Union.
  - The state registration of specialized food products is conducted by the body authorized by the Customs Union member state (hereinafter referred to as the specialized food product registration body).
  - State registration of specialized food products is indefinite.
  - State registration of specialized food products can be revoked or suspended by the specialized food product registration authority in cases of non-conformity to the requirements of these technical regulations, established as a result of state control (supervision) and/or by the decision of judicial bodies of the Customs Union member state.
  - The applicant has the right to challenge the decision of the specialized food product registration authority through legal proceedings.



---

For state registration of specialized food products, the applicant must submit the following documents to the specialized food product registration authority:

- An application for state registration of specialized food products, specifying its name, the name of the applicant, and the address of its location (for the applicant who is a legal entity), the full name of the applicant, the address of their location, and the details of the identity document (for the applicant who is an individual entrepreneur);
- Results of research (tests) of samples of specialized food products conducted in an accredited testing laboratory, as well as other documents that confirm the conformity of such products to the requirements established by these technical regulations and other applicable technical regulations of the Customs Union;
- Information about the purpose of the food product.

Documents presented to the authority for the registration of specialized food products are accepted based on an inventory list, a copy of which, marked with the date of acceptance, is sent or handed over to the applicant.

The act of state registration of specialized food products is confirmed by the inclusion of information about the product in the unified register of specialized food products within three days following the completion of the review of the submitted documents by the specialized food product registration authority.

## Article 30. Veterinary and sanitary examination

---

- Unprocessed food products of animal origin are subject to veterinary and sanitary examination before being released into circulation on the customs territory of the Customs Union, unless otherwise specified by the Technical Regulations of the Customs Union on fish food products, and are accompanied by a document containing information that confirms their safety.  
Processed food products of animal origin are not required to undergo a veterinary and sanitary examination. An assessment of the conformity of non-industrial food products of animal origin to the requirements established by the technical regulations and other technical regulations of the Customs Union for specific types of food products can be conducted in the form of a veterinary and sanitary examination.
- The veterinary and sanitary examination of unprocessed food products of animal origin is carried out for the purposes of:
  - establishing the conformity of the food products and the processes of production (manufacturing), storage, transportation, distribution, and disposal related to safety requirements to the requirements of these technical regulations and technical regulations of the Customs Union for specific types of food products;
  - establishing the well-being in veterinary terms of farms (production facilities) of animal origin.
- The veterinary and sanitary examination and the documentation of its results are carried out in accordance with the legislation of the Customs Union member state, as well as the Customs Union Agreement on veterinary and sanitary measures.
